HOLLAND, COUNTY CLERK, RECORDER AND ASSESSOR & REGISTRAR OF VOTERS OF THE COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA, OF THE FILING PERIODS FOR PETITIONS IN LIEU OF FILING FEE (ALL STATE AND COUNTY OFFICES WITH A FILING FEE) AND DECLARATION OF INTENTION (JUDGE OF THE SUPERIOR COURT ONLY) FOR OFFICES FOR WHICH CANDIDATES ARE TO BE VOTED ON AT THE PRESIDENTIAL PRIMARY ELECTION ON JUNE 5, 2012.

NOTICE IS HEREBY GIVEN that the following filing periods for candidates running for voter nominated offices at the Presidential Primary Election to be held on Tuesday, the 5th day of June 2012 are as follows:

PETITION IN LIEU OF FILING FEE

The filing period is **December 30, 2011** through **February 23, 2012** for all State and Local offices that require a filing fee.

DECLARATION OF INTENTION (For Judge of the Superior Court ONLY)

The Declaration of Intention period is between **January 30, 2012** and **February 8, 2012** and it **must** be filed in our office by **5:00 p.m. on February 8, 2012** to ensure eligibility to run in the Presidential Primary Election.

Declaration of Candidacy and Nomination Papers (For all candidates including Judges)

All candidates **must** file a Declaration of Candidacy and meet Nomination requirements between **February 13, 2012** and **March 9, 2012 by 5:00 p.m.** to qualify for the Presidential Primary Election.

NOTE: The extension period to file Nomination Papers for candidates other than the qualified incumbent, if the Incumbent does not file, is **March 10, 2012** through **March 14, 2012 by 5:00 p.m.**

QUALIFICATIONS FOR STATE AND LOCAL OFFICES:

Candidate Filing will be available **by appointment ONLY** in our **Santa Maria Office** (511 Lakeside Parkway, Ste. 134), and our **Lompoc Office** (401 E. Cypress Avenue, Room 102) from **9:30 to 11:00 a.m.** and from **1:00 to 3:30 p.m.** on **Mondays** and **Thursdays**. Candidate Filing will be available in the **Santa Barbara Elections Office** (4440-A Calle Real) from 8:00 a.m. to 5:00 p.m. Monday through Friday, holidays excepted.
