#### **Who can participate?**

Santa Barbara County permanent employees who are registered voters in any county in the State of California, or lawfully permitted for permanent residence in the United States in accordance with 8 U.S.C. Sec. 1101(a)(2) and otherwise eligible to vote pursuant to Elections Code Section 2101 except for his/her lack of U.S. citizenship.

#### **How to apply:**

- Complete attached application
- Obtain approval from Department Head or their designee.

#### **Program details:**

- The employee will work at an assigned polling place in Santa Barbara County.
- The shift is from **6:00 a.m. to approximately 9:00 p.m. Part time positions are NOT AVAILABLE.**
- Time off to attend classes is not excused under the program.

#### **Training:**

- Classes are by appointment only. There are both day and evening classes scheduled approximately 2 ½ weeks before the election. Time off to attend training during work hours must be coded as vacation hours.

#### **Stipends:**

Participants will receive a stipend ranging from \$180.00 - \$240.00 depending on the position assigned.
